The standard deductions such as TDS on GST & IT and other statutory levies as per

government norms from time to time will be deducted.

The work/supply should be completed at the earliest but not later than 21.03.2025 after which Liquided damages will be imposed as per GENERAL CONDITION OF CONTRACT (GCC). (A sum equivalent to 0.5% (half percent) of the delivered price of the delayed goods or unperformed services for each week of delay or part thereof until actual delivery or performance, up to a maximum deduction of 10% (ten percent) of the delayed goods or services contract price. Once the maximum is reached, the purchaser may consider termination of the contract, if the same have not been terminated already).

delivery/supply of stores) to arrange for payment. The payment will be released from this Office only on receipt of bills from the concerned Officer/ Indenter/ End user <u>along with GST Registration</u>, Cancelled Cheque, etc, to the effect that the items are received in good condition without any damages.
