- The standard deductions such as TDS on GST & IT and other statutory levies as per government
- The work/supply should be completed at the earliest but not later than 24-07-2025 after which Liquided damages will be imposed as per GENERAL CONDITION_OF CONTRACT (GCC). The payment will be released from this Office only on receipt of bills from the concerned Officer/ Indenter/ End user along with GST Registration, Warranty Certificate, Cancelled Cheque, etc, to the effect that the items are received in good condition without any damages.
