• The annual AMC amount of Rs.46,144/- (In Rupees: Forty Six Thousand One Hundred Forty Four Only) including GST @ 18% will be paid on half yearly basis for an year, after the satisfactory regular service certified by the concerned officer at CIBA, Chennai and on production of invoice in triplicate along with advance stamped receipt and service report. The Invoice should be drawn in favour of "THE DIRECTOR, CIBA, Chennai- 600028". No advance payment will be made. The Standard deductions such as TDS on GST & IT and other statutory levies as per government norms from time to time will be deducted.

Terms and Conditions:-

- 1. The payment will be made half yearly basis on submission of invoice for 6 months period.
- 2. Two preventive maintenance visits (with one standard calibration) and attending to all breakdown calls during the one-year AMC period.
- 3. No advance payment will be made.
- 4. The service report/ for the preventive / any other visit during the AMC period should be enclosed along with the invoice.
- 5. The invoice should be submitted within 30 days after 6 months of AMC period. Otherwise the amount maybe forfeited. The decision of Competent Authority is final in this regard.
- 6. Other condition as per General Conditions of Contract.
- 7. Payment will be made after deducting the TDS on IT (2%) AND GST is applicable as per government Rules.
